# How to define an energy efficiency service ?

- ▶ *Implementation of actions leading to a sustainable improvement in energy efficiency*
- ▶ *The improvement must be measurable or verified or else estimated in the case when measuring is not adapted*
- ▶ *The contractor commits himself by contract to :*
  - ▶ *Characterize accurately the baseline*
  - ▶ *Reach the objectives in terms of quality and energy efficiency committed*
  - ▶ *Implement means of control and measurement of the performance*

# EE Guide: a rigorous methodology

- ▶ *Description of the “best” process, comprising 4 essential phases :*
  - ▶ *A pre-audit phase*
  - ▶ *A proposal elaboration phase*
  - ▶ *A work realisation phase*
  - ▶ *A follow-up and performance guarantee phase*
  
- ▶ *A methodology aiming at strengthening the customers' confidence, suitable to Public and Private sites as well industrial plants*
  
- ▶ *Each actor is free to apply the technical guidelines through its own offers, business models...*

- ✦ *A market under the influence of Public contracting rules (e.g. Private-Public Partnership since 2005)*
