- Our first Citizen Action Lab 1 (CAL) in Norway is in Overhalla.



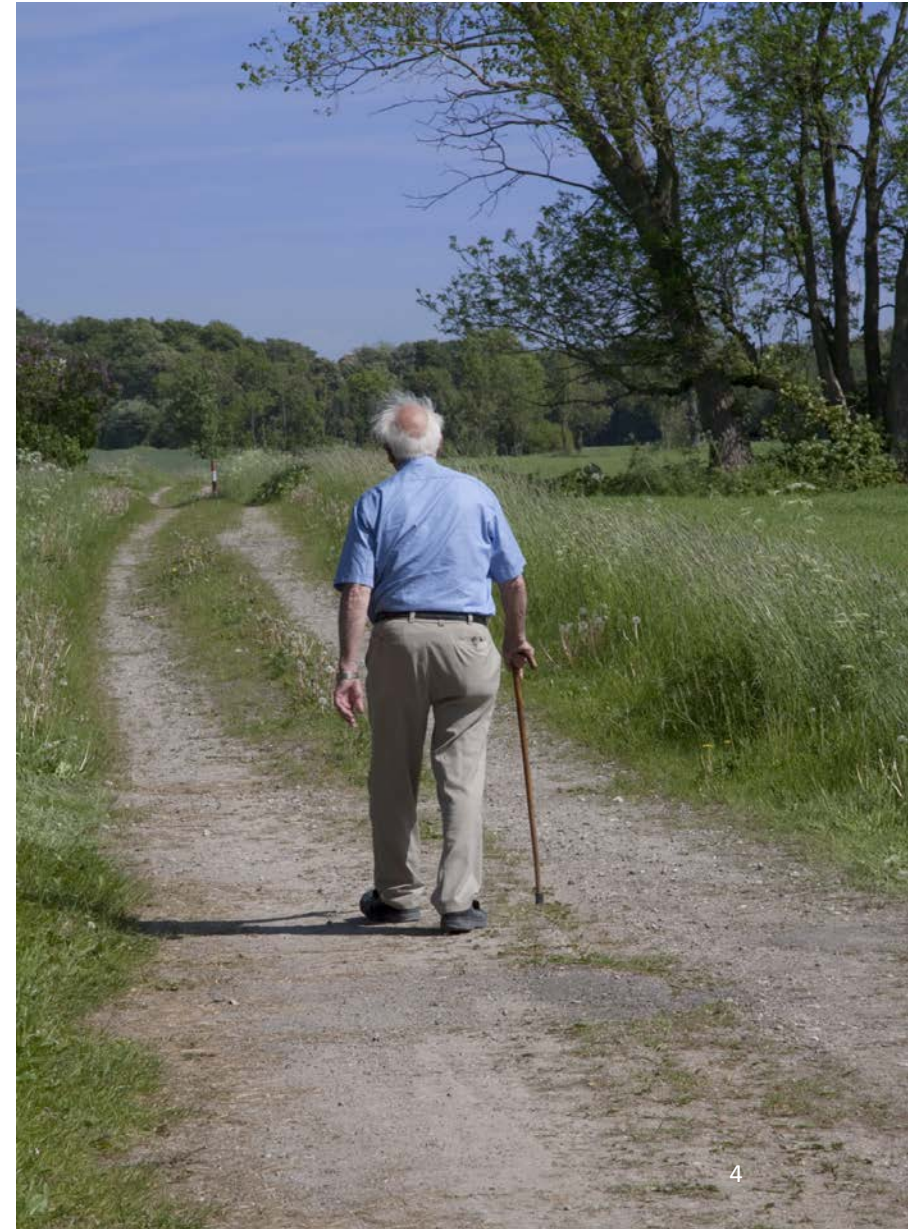
Energy transitioning in rural communities. Different challenges – different measures?

How can work be a partner and a part of the energy transition?

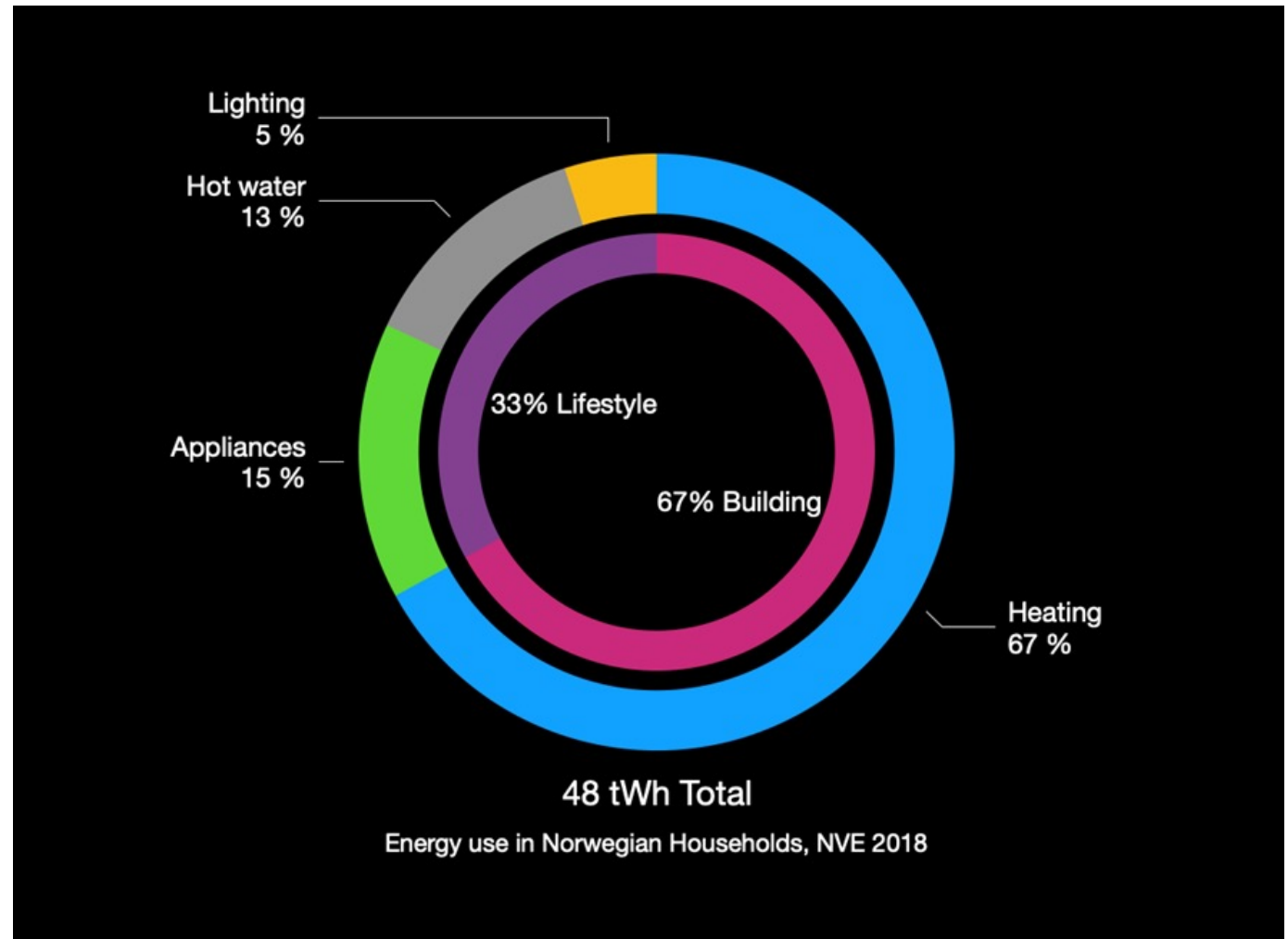


How might social life and leisure activities support citizens participation and local democracy?

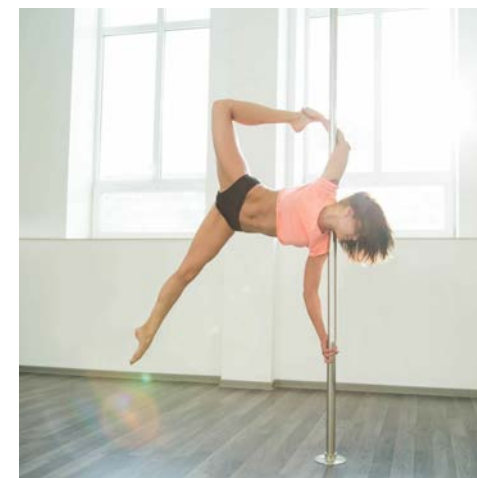
